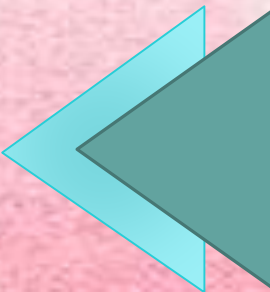

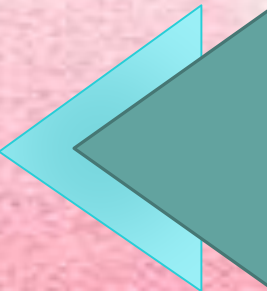

We welcome proposals for symposia, workshops, and research papers (oral/poster presentations) focusing on the theme of "Innovative Approaches in Social Work Education and Practice: Evidence from Different Fields of Social Work in India" and the following subthemes:

Proposals for workshops and symposia, and abstracts of scientific papers, are invited for presentation in the free or award category. Papers for free presentations can be in English or Hindi and may be presented in any of the Indian languages included in the Eighth Schedule of the Constitution. The language mode of presentation must be intimated in advance. For the award category, full papers must be written in English. Submitted papers will be copyrighted by ISPSW/organizers for publication in conference proceedings or in the society's journal, the National Journal of Professional Social Work.

Each registered participant may present a paper and propose a workshop and symposium at most. For paper presentations, 15-20 minutes will be allotted. Presentations can be made through PowerPoint on online platforms. For workshops and symposia, 1.5 hours will be allotted. Separate guidelines are provided for contesting in various award categories. Efforts will be made to livestream the presentations, workshops, and symposia on the YouTube and Facebook channels of the ISPSW.

❖ Abstracts of original and unpublished work for presentation at the conference must be submitted online to <http://pswjjournal.org/index.php/ANC/about/submissions> or can be emailed to the Chairperson Scientific Committee at ancispsw2024@gmail.com on or before 7th June 2024. Abstracts thus submitted will get the opportunity to publish their full paper in a society's journal or an edited book with ISBN.

Word Limit: 250 words

Format: MS Word file

Page Setup: 1-inch margin on all sides, A4 size page

Font: Times New Roman, 12 points, single-spaced

Title: Centered, bold, at the top of the page, followed by the authors

Presenting Author: Name should be underlined

Abstract Content: Should include a brief introduction, methodology, results, and conclusion, with 3-6 keywords

Author Details: The names, emails, phone numbers, and institutional affiliations of the authors must be mentioned in parentheses
